## Standard 6.15-Broken Bones / Major Injury Policy

We believe that all children should be able to be admitted to our setting and in doing so their safety

and the safety of others within the setting should not be compromised.

It is the parent's responsibility to notify the setting of a child who has sustained a major injury or broken bone. Forms are available to parents to identify any injury of a child including details on how the incident occurred.

In the event of a major injury or broken bone, the parent must also provide the required information outlined below prior to wanting the child to be admitted.

Only on the completion of our procedure will the child be allowed to attend.

In addition to our existing injuries forms, in the case of a broken bone or major injury, the following will also be required.

- If the child has sustained an injury or broken bone which has required hospital care or outpatient treatment, the parent must provide confirmation from their consultant or doctor that the child is considered well enough to attend Preschool. Within this confirmation any ongoing physical limitations of the child must be outlined.
- The parent must provide a signed letter confirming the ongoing care requirements of the child along with their confirmation that they are comfortable with the child attending the setting.

On receipt of the parental and doctor's confirmations a risk assessment will be carried out. This will consider any ongoing physical limitations and will determine appropriate strategies for managing risk within the setting.

Should the risk assessment determine that one to one supervised care is a requirement of safe admission to the setting, the setting reserves the right to request the parent to provide this. The child will not necessarily qualify for SEND one to one funding and to maintain staff to children mandatory ratios it will not be possible for the setting to provide this level of care without parental support.

The risk assessment will be discussed with the parent and must be carried out before a child is admitted to the setting.

Any provisions for the child will be made with the approval of the parent, setting Manager and Health and safety officer.
